Statement regarding compliance with international sanctions

This statement is issued in light of the restrictions placed under COUNCIL REGULATION (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (the "**Regulation**"), specifically Article 3g.

The Undersigned hereby acknowledges with this statement that it will not:


1. import, directly or indirectly, iron and steel products listed in Annex XVII of the Regulation into the European Union if they:
 - a. originate in Russia; or
 - b. have been exported from Russia;
2. purchase, directly or indirectly, iron or steel products listed in Annex XVII of the Regulation which are located or which originated in Russia;
3. transport iron and steel products as listed in Annex XVII of the Regulation if they originated in Russia or are being exported from Russia to any other country;
4. import or purchase, as from 30 September 2023, directly or indirectly, iron and steel products as listed in Annex XVII of the Regulation when processed in a third country incorporating iron and steel products originating in Russia as listed in Annex XVII of the Regulation; with regard to products listed in Annex XVII of the Regulation processed in a third country incorporating steel products originating in Russia of CN code 7207 11 or 7207 12 10, this prohibition shall apply as of 1 April 2024 for CN code 7207 11 and as of 1 October 2024 for CN code 7207 12 10
5. to provide, directly or indirectly, technical assistance, brokering services, financing or financial assistance, including financial derivatives, as well as insurance and re-insurance, related to the prohibitions in points (1), (2) (3) and (4).

The Undersigned hereby declares to conform fully with the above and the current and future version of the Regulation as a whole. The Undersigned undertakes to immediately provide Ahlsell with any evidence required (whether by Ahlsell or customs authorities), including but not limited to Mill Test Certificates, to prove product(s) compliance with the Regulation.



The Undersigned understands that compliance with the above is of the utmost importance for Ahlsell and undertakes to immediately inform Ahlsell if the Undersigned, at any point in time, is not able to comply with this statement or future versions of the Regulation.

The signatory on behalf of the Undersigned declares to have the authorisation and mandate to sign this statement on behalf of the Undersigned.
